This program, seeking accreditation from the Commission on Accreditation in Physical Therapy Education (CAPTE), leads to an Associate of Applied Science (AAS) degree. Upon PTA Program graduation, students will be eligible to take the national licensure examination for the Physical Therapist Assistant.
