2026-2027 Student Loan Verification Request

Student loan funds to be used for educational purposes. School tuition, fees and charges will be held out of loan proceeds before any loan funds are disbursed. **You must be enrolled in at least 6 credit hours to receive a student loan.** If you drop below 6 credit hours, your loan may be prorated and any future disbursements will be cancelled.

TO BE ELIGIBLE FOR A STUDENT LOAN, COMPLETE THE FOLLOWING:

- Apply for Admissions and be fully accepted as a degree seeking student.
- Complete the FAFSA on-line at www.studentaid.gov for the school year in which they plan to attend.
- Complete the financial aid verification process, if selected. All required documents must be turned in and verified before loan eligibility can be determined.
- Maintain *Satisfactory Academic Progress* towards a degree. If you are failing the SAP policy, you must file an appeal and it be approved before you will be eligible for *any* Title IV aid.
- Submit *all official transcripts from all institutions attended to the Admission's Office*. Title IV aid is awarded based on your entire academic history; therefore, so you must have **all** of your transcripts on file.
- Go to www.studentaid.gov and complete the **electronic loan entrance counseling** and **electronically sign your master promissory note**. This must be done prior to your loan being fully processed. You may attach proof of this being complete if you wish.

Enrollment Status Matters

- **Full-time** (usually 12+ credits per semester) – eligible for the maximum loan amounts.
- **Three-quarter time** (typically 9–11 credits) – eligible for reduced loan amounts.
- **Half-time** (usually 6–8 credits) – eligible for smaller loan amounts.
- **Less than half-time** – generally **not eligible** for Direct Loans.

Important Notes

- Your enrollment at the time of disbursement determines your loan eligibility—not necessarily your plans at the start of the semester.
- *Dropping or adding classes after loans are disbursed may require adjustments.*

All paperwork, electronic processes, and transcripts must be completed by this time.
